ENGAGEMENT AND BRIDAL PORTRAITS

If not already included as part of your chosen wedding package, Bridal and Engagement sessions may be purchased separately. Payment for bridal and/or engagement sessions is due on the day of the session, and the amount paid will be deducted from the overall billing.

Engagement and bridal sessions include the following:

- Up to one hour of photo session time at location of choice (travel fees may apply).
- Up to 50 images that will be posted online for viewing and purchasing
- One (1) 8x10 of choice
- Additional prints subject to price list (see price list on next page)
- All images on CD with rights to reproduce can be purchased for an additional \$199.00

For wedding packages that include a bridal and/or engagement session, payment for the bridal and/or engagement sessions is due 30 days before the session.

Portrait sessions may be held in the bride and groom's place of choice. Outdoor settings with natural, ambient lighting is a popular option, which often produces highly desirable results in portraits. Out-of-area travel may involve an additional fee. Please contact Michael Bupp for details.

Bridal and engagement portrait sessions should be arranged to take place as early as possible before the wedding. It is recommended these sessions occur at least 6 to 8 weeks before the wedding date. This will allow time for initial photo finishing, delivery of previews to the couple, choosing prints for enlargement, processing and delivery of final prints for framing

Payment for Reprint and Enlargements: No reprints or enlargements will be delivered until the full amount for those reprints or enlargements has been paid.

Delivery of Reprints and Enlargements: It is the responsibility of the customer to pick up photograph orders from Michael Bupp. Photograph orders may be shipped to customer for an additional charge to cover shipping, handling, and insurance. Shipping cost varies with size and nature of customer order. There is a minimum charge of \$35.00 for each shipment.

Online Event Hosting: All wedding day images are posted online for viewing and purchasing. Unless otherwise specified, photos remain available for 90 days.

Framing Services: Available for all enlargements. Prices are available upon request.

Photo CD: If not already included in the selected package, a CD may be purchased for \$199.00, which contains all of the images in high resolution. By purchasing the CD, clients obtain the rights to reproduce those images for their personal use.

IMPORTANT NOTES

1. **RETAINER AND PAYMENT REQUIREMENTS:** A 50%, **non-refundable** retainer (applied toward the bill) is required to book your wedding date. The balance of the wedding package payment is due 30 days before the wedding day.
2. **ADDITIONAL HOURS OF WEDDING COVERAGE:** Additional wedding coverage (beyond time allowed in your chosen package) is charged at \$125.00 per hour. Additional coverage hours may be added to any wedding package, if desired, by the wedding couple.
3. **REPRINT/ENLARGEMENT:** See price list for reprint and enlargement prices.
4. **WEDDING ALBUM:** Additional pages may be added to any 10 x 10 wedding album. The Destiny album can only be ordered as a 16, 24, 32 or 40 page album. Each additional (8) pages are billed at \$100.00 each. Tuscany albums can be ordered from 16 pages to 70 pages. Each additional (2) pages are billed at \$25.00 each. All albums are made of genuine leather of the highest quality and delivered in matte black unless otherwise specified. Album pages are a single side that contains (1) image of choice. All albums include a Cameo or Photo Inlay (cover photo), unless otherwise specified. 12 x 12 albums are available (prices available upon request). To claim your wedding album, clients simply make a list of all images they want, in the order they are to appear and submit to Michael Bupp. **If client does not submit their wedding album order within one-year from date of wedding, client foregoes their right to the wedding album.** There will be no exceptions. Tuscany albums also offer design options, which allow for multiple images per page and design freedom. If clients request/order a designer album, there will be a \$5.00 per page charge for design time. Clients may request up to 3 changes when viewing the albums at www.approvemyalbum.com. Each additional change will be billed at \$25.00 per change. Wedding album upgrades available upon request

PARENT PRESS BOOK: Parent press books may be supplemented to any package (see page 4 for pricing). It is an 8x8 hardcover book, available in 50 images, 40 images or 30 images, plus cover picture. Additional images may be added to any press book in intervals of (2) images. Each additional (2) images are billed at \$12.00/(2) images. To claim your press book, clients simply make a list of all images they want, in the order they are to appear and submit to Michael Bupp.
5. **OUT-OF-AREA TRAVEL:** Out-of-area travel (beyond 25 miles from 1682 Gablers Rd, Gardners, PA 17324) is billed at \$15.00 per hour for travel and \$0.50 per mile round trip for fuel expense.
6. **METHOD OF PAYMENT:** Payment by check, money order and PayPal (clients are responsible for processing fees) are the only methods of payment available.
7. **PROOF DELIVERY:** Please allow 5 to 8 weeks for processing and delivery of proofs unless otherwise specified.
8. **SHIPPING:** Clients are responsible for all shipping costs. A flat rate of \$35.00 will be charged for wedding album and proof book delivery. Please note that this fee is separate for each additional shipment.

WEDDING PHOTOGRAPHY TERMS AND CONDITIONS

Michael Bupp Photography is the exclusive photographer during the wedding ceremony and formal photo sessions before and following the ceremony. Other photography will be permitted at the sole discretion of Michael Bupp Photography (and is usually allowed without problem). All other individuals taking photographs must not interfere with the photography process of Michael Bupp Photography or they will be asked to cease. Reception photography is open to all family and friends of the wedding couple.

Unless otherwise specified, wedding day photography coverage begins no later than one hour before the start of the ceremony.

Michael Bupp Photography retains the copyright of all digital images and prints for advertising purposes and sale. No unauthorized copies may be made of any prints or enlargements produced by Michael Bupp Photography. This includes, but is not limited to, electronic scanning or otherwise copying of prints, which represent violations of existing copyright laws. These conditions do not apply when the wedding couple has purchased the CD of the images. If the CD of images has been purchased, the wedding couple possesses the rights to reproduce the images for their personal use only.

Michael Bupp Photography reserves the right to remove any undesirable prints from deliverable previews (blink shots, blurred images, etc.)

Michael Bupp Photography will do its best to capture all agreed-upon wedding day moments. However, due to limits imposed by time and events of the wedding day, Michael Bupp Photography cannot be held liable for unintentional errors or omissions. The limit of liability of Michael Bupp Photography is to monies already paid by the customer

The retainer to reserve the wedding date and time are **non-refundable**. If for some reason a wedding time and date are changed after submission of the retainer, Michael Bupp Photography will do its best to accommodate those changes; however, any such accommodations are based on the availability of the photographer for the new time and date.

The balance of the wedding package payment (or any negotiated expanded basic package) is due 30 days before the wedding day. Any additional balance (when applicable) is due upon delivery of the preview print album.

Reprints and enlargements after wedding: No reprints or enlargements from the wedding day can be delivered until the full amount for those reprints or enlargements has been paid. In the event of nonpayment for orders received, the bride and groom are responsible for any outstanding amounts due.

As human error is always possible, it is the responsibility of the bride and groom to contact Michael Bupp Photography during the week of the wedding to confirm wedding day plans and requirements.
